The exercise price set for the conversion of the Warrants referred to the Third Exercise Period is Euro 4.55 (four point fifty five) for each Conversion Share.

The exercise of the Warrants will be effective within the tenth open day of the stock exchange following the end of the Third Exercise Period.

No events are planned for the Third Exercise Period that may cause the suspension of the exercise right pursuant to article 2) VIII of the Warrant Regulations.
